



Northland Online School Summer School 2025 FAQ



The Northland Online School is pleased to announce we are starting Summer School this July, 2025!

Frequently Asked Questions:

Who should register for summer school?

- Summer school is an excellent opportunity for students who are close to earning their credits for graduation, credit recovery, or if you would like to get ahead and earn extra credits during the month of July.

What is the deadline to register for summer school?

- The last day for students to register for summer school is Monday, July 7, 2025.

What are the dates of summer school?

- July 7th - July 31st, 2025

How many days during the week are classes?

- 4 days a week for four weeks
- Monday - Thursday
- Summer School Dates: July 7-10, July 14-17, July 21-24, July 28-31

Do I need to attend zoom classes during summer school?

- Students work through their courses asynchronously. Asynchronous means that students work independently and do not need to attend zoom classes for live lessons during the school day.

How do teachers support me virtually during my courses if I'm not at a physical school?

- Teachers will be available every school day for office hours. Students are encouraged to attend teacher office hours if they have any questions or need support.

Do I need to register for Summer School?

- Yes. Please email tessa.dagenais@nsd61.ca if you are interested in registering for summer school. We will reach out to you asap with a registration form to complete, along with your birth certificate. Additionally, you can find our registration form on the [Northland Online School website](#).

If I already am a Northland School Division student, do I still need to register for summer school?

- Yes, all students that are currently enrolled within Northland School Division need to still register as a student for summer school.

Who is able to register for summer school?

- Any high school student who is an Alberta resident 19 years or younger can register for summer school.

Can Grade 9 students register for Summer School?

- Yes, grade 9 students can register. They will get their courses from summer school in the Fall of 2025.

Is summer school in-person or virtual?

- Summer school will be offered virtually. Students will not need to attend a Northland school in person for summer school. All classes and office hours with teachers will be offered virtually.

Do I need a Northland chromebook?

- We prefer all students to be using a Northland chromebook, but if you have your own computer at home that you would like to use instead that works as well.

Can I borrow a Northland chromebook for summer school?

- Yes. If you would like to borrow a Northland chromebook, we will arrange for you to borrow one from your current Northland School, or we can mail one to you to borrow if you're registering from outside of the Northland School Division.

What courses are offered in Summer School?

- All core courses (ELA, Social, Science, Math)
- Credit Recovery for Core Courses
- Career and Life Management (CALM)
- Workplace Safety Systems (HCS 3000)
- Workplace Safety Practices (HCS 3010)
- Job Preparation (CTR 1010)

- Physical Education 10/20/30
- Forensics 25/35
- Food Handling Certification
- Off Campus Courses:
 - Registered Apprenticeship Program (RAP)
 - Work Experience

If I'm taking a 30 level diploma course, when do I write the diploma?

- Students taking 30 level diploma courses will be able to write their diploma in the Fall of 2025.

Will I get a report card?

- Yes, students will receive a report card shortly after their classes conclude.
